

ORDINANCE NO. O-25-01

**AN ORDINANCE AMENDING ORDINANCE NO. O-23-26, ESTABLISHING THE PAY
RATES FOR CERTAIN EMPLOYEES, EFFECTIVE JANUARY 1, 2025 AND
DECLARING AN EMERGENCY.**

WHEREAS, there are sufficient monies within the 2025 Budget to accommodate an increase in rate for certain employees; and,

NOW, THEREFORE, BE IT ORDAINED by the Council of the Village of Clinton, Summit County, Ohio as follows:

Section 1: The Village Fiscal Officer is directed to provide the following hourly pay amounts for the specified Village employee positions, effective January 1, 2025:

FD	PT-Fire Medic	\$20.02	SD	PT Street Laborer	\$11.39
FD	PT-EMT	\$18.63	SD	FT Street Laborer	\$24.83 - \$30.61
FD	FT-Fire Medic	\$23.36	OGG	Office Administrator	\$18.22
FD	OIC – Officer in Charge	\$1.00			

Section 2: The Village Fiscal Officer is also directed to provide the below monthly rates for the specified Village employee positions, effective January 1, 2024:


Zoning Inspector	\$401.00	FD Lieutenants	\$160.00 monthly
FD Fire Chief	\$295.00	FD Assist Fire Chief	\$170.00 monthly
		Street Commissioner	\$175.00 monthly

Section 3: That this Ordinance is in the best interests and public safety of the Village of Clinton and its residents.




