

ORDINANCE NO. O-25-03

**AN ORDINANCE AMENDING CODIFIED ORDINANCE
SECTION 121.02 ENTITLED "RULES", AND DECLARING IT TO BE AN
EMERGENCY.**

WHEREAS, Codified Ordinance Section 121.02 establishes the rules of Council, its procedures, its officers, committee schedule, among other matters.

WHEREAS, the committee schedule as it presently exists is inflexible.

WHEREAS, the committee schedule as it presently exists fails to adequately serve the Village.

WHEREAS, the committee schedule as it presently exists fails to provide committees sufficient time to accomplish work in committee.

WHEREAS, the committee schedule as it presently exists fails to meet the needs of the committees.

WHEREAS, the committee schedule as it presently exists impedes the Village's ability to discuss and consider and promulgate legislation for the betterment of the Village.

WHEREAS, the committee schedule as it presently exists impedes the Village Council's ability to oversee the execution of the Village's laws, ordinances, and policies.

WHEREAS, the Village Council believes that the officer of "Vice President" is unnecessary to the execution of Council business.

NOW, THEREFORE, BE IT ORDAINED by the Council of the Village of Clinton, Summit County, Ohio, as follows:

Section 1: The Council hereby amends Codified Ordinance Section 121.02 as reflected in Exhibit A.

Section 2: That all other language as approved in Codified Ordinance Section 121.02, will remain the same.

Section 3: That this Ordinance is in the best interests of the Village of Clinton and its residents.

Section 4: That this Ordinance is best suited to execute the duties of the Council of the Village of Clinton.

Section 5: That the aforesaid recitals are rendered to be the findings of this Council and are hereby incorporated into this Ordinance.

Section 6: That this Council hereby finds and determines that all formal actions relative to the adoption of this Ordinance were taken in an open meeting of this Council and that all deliberations of this Council which resulted in formal action were taken in meetings open to the public, in full compliance with the applicable legal requirements including Section 121.22 of the Ohio Revised Code.

Section 7: That this Ordinance is hereby declared to be an emergency measure necessary for the immediate preservation of the public peace, health, safety and welfare of the Village's residents, for the immediate implementation of these rules, and provided this Ordinance receives the affirmative vote of the members elected or appointed to Council, it shall take effect and be enforced immediately upon its passage.


