

RESOLUTION NO. R-24-17

A RESOLUTION TO PROVIDE LEGAL SERVICES FOR THE VILLAGE OF CLINTON AND CONFIRMING THE APPOINTMENT OF MARSHAL M. PITCHFORD AS VILLAGE SOLICITOR FOR YEARS 2025 AND 2026; AND DECLARING AN EMERGENCY.

WHEREAS, Council has agreed to authorize an agreement and to further approve this appointment of MARSHAL M. PITCHFORD as Village Solicitor.

NOW THEREFORE, BE IT RESOLVED by the Council of the Village of Clinton, Summit County, Ohio as follows:

Section 1: Marshal M. Pitchford is hereby re-appointed as Solicitor of the Village of Clinton for a two-year period, effective January 1, 2025 through December 31, 2026.

Section 2: The Mayor is authorized and directed to enter into an agreement with Marshal M. Pitchford to provide legal services to the Village. The agreement shall be in a form substantially similar to the one attached hereto as Exhibit "A," which is incorporated herein.

Section 3: To the extent they conflict, all prior resolutions and ordinances that relate to this measure are hereby repealed and rescinded.


Section 4: That this Council hereby finds and determines that all formal actions relative to the adoption of this Resolution were taken in an open meeting of this Council and that all deliberations of this Council which resulted in formal action were taken in meetings open to the public, in full compliance with the applicable legal requirements including Section 121.22 of the Ohio Revised Code.

Section 5: This Resolution is declared to be an emergency measure necessary for the preservation of the public peace, health, safety, convenience, and welfare of the Village of Clinton and the inhabitants thereof, and for the further reason that this Resolution must be immediately effective in order to provide for the immediate legal services provided for herein, which are necessary to preserve and protect the legal interests of the Village. This Resolution shall be in full force and effect immediately upon its passage and approval by the Mayor.
