**RESOLUTION NO. R-25-2**

**A RESOLUTION AUTHORIZING ALL ACTIONS NECESSARY  
TO ACCEPT NORTHEAST OHIO PUBLIC ENERGY  
COUNCIL (NOPEC) 2025 ENERGIZED COMMUNITY  
GRANT, AND DECLARING AN EMERGENCY.**

**WHEREAS**, the Village of Clinton, Summit County, Ohio, the VILLAGE/GRANTEE, is a member of the Northeast Ohio Public Energy Council (“NOPEC”) and is eligible for one or more NOPEC Energized Community Grant(s) for 2025 (“NEC Grant(s)”) as provided for in the NEC Grant Program guidelines; and

**WHEREAS**, the VILLAGE/GRANTEE wishes to enter into a Grant Agreement with NOPEC, Inc. in substantially the form presented to this Council to receive one or more NEC Grant(s); and

**NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF CLINTON, COUNTY OF SUMMIT, AND STATE OF OHIO, THAT:**

**SECTION 1.** This Council of the VILLAGE/GRANTEE (the “Council”) finds and determines that it is in the best interest of the VILLAGE/GRANTEE to enter into the Grant Agreement to accept the NEC Grant(s) for 2025, and authorizes and directs the Mayor to execute the Grant Agreement to accept the NEC Grant(s) funds.

**SECTION 2.** This Council finds and determines that all formal actions of this Council concerning and relating to the adoption of this Resolution were taken in an open meeting of this Council and that all deliberations of this Council and of any committees that resulted in those formal actions were in meetings open to the public in compliance with the law.


