**RESOLUTION NO. R-25-05**

**Resolution No. R-25-05 Authorizing the transfer of funds from the General Fund to the Street Fund (“Project Fund”) of the Village of Clinton, and declaring the same to be an emergency.**

**BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF CLINTON,  
SUMMIT COUNTY, OHIO.**

**Section 1. Findings and Determinations.** This Council finds and determines the following matters:

- (a) It is in the best interest of the Village of Clinton (“Village”) to transfer a portion of the money in the General Fund to the Street (“Project Fund”) to account for the needs and obligations for such Project Fund.
- (b) All formal actions of this Council relating to the enactment of this Resolution were taken in an open meeting of this Council and all deliberations of this Council and of any of its committees that resulted in those formal actions were in meetings open to the public in compliance with the law, including Section 121.22, Ohio Revised Code.

**Section 2: Transfer of Funds.** This Council authorizes and directs the Fiscal Officer to make the following transfer of funds:

- (a) **\$158,000.00** from the General Fund to the Street Fund

**Section 3. Statement of Emergency.** This Resolution is declared to be an emergency measure necessary for the immediate preservation of the public peace, health, and safety of the Village, and for the further reason that the immediate effectiveness of this Resolution is necessary to ensure the timely performance of Village operations and the timely payment of Village obligations.


**Section 4. Effective Date.** If this Resolution receives the affirmative vote of two-thirds of the members elected or appointed to Council, it will take effect and be in force immediately upon its enactment; otherwise, it will take effect and be in full force at the earliest time allowed by law.
