

**RESOLUTION NO. R-25-06**

**A RESOLUTION ACCEPTING THE AMOUNTS AND RATES AS DETERMINED BY THE BUDGET COMMISSION AND AUTHORIZING THE NECESSARY TAX LEVIES AND, CERTIFYING THEM TO THE COUNTY FISCAL OFFICER FOR 2026, AND DECLARING AN EMERGENCY.**

BE IT RESOLVED, that the Village of Clinton Council and the Fiscal Officer, pursuant to Ohio Revised Code Sections 5705.281 and 5705.04, and in accordance with the Summit County Budget Commission, has previously submitted Alternative Tax Budget Information as prepared by the Fiscal Officer for the next succeeding fiscal year commencing January 1, 2026.

WHEREAS, the Budget Commission of Summit County, Ohio, has certified its action thereon to this Board together with an estimate by the County Fiscal Officer of the rate of each tax necessary to be levied by this Board, and what part thereof is without, and what part within, the ten mill limitation;

NOW, THEREFORE, BE IT RESOLVED, by the Council of the Village of Clinton, Summit County, Ohio that the amounts and rates as determined by the Budget Commission in its certification, be and the same are hereby accepted pursuant to Ohio Revised Code Section 5705.34;

BE IT FURTHER RESOLVED, that there be and is hereby levied on the tax duplicate of said Village and the rate of each tax necessary to be levied within and without the ten mill limitation as outlined on the attached Summit County Budget Commission Certification of Tax Levy dated August 4, 2025 pursuant to Ohio Revised Code Sections 5705.34 and 5705.35;

BE IT FURTHER RESOLVED, that the October first deadline contained in Ohio Revised Code Section 5705.34 has been extended by the Tax Commissioner as attached to this Resolution; and,

BE IT FURTHER RESOLVED, that this Council finds and determines that all formal actions relative to the adoption of this Resolution were taken in an open meeting of this Council and that all deliberations of this Council which resulted in formal action were taken in meetings open to the public, in full compliance with the applicable legal requirements, including Section 121.22 of the Ohio Revised Code.

BE IT FURTHER RESOLVED, that the Fiscal Officer of this Council be and is hereby directed to certify a copy of this Resolution to the County Fiscal Officer of Summit County.

BE IT FURTHER RESOLVED, that this Council finds the adoption of this Resolution is an emergency and is necessary for the immediate preservation of the public peace, health, safety and general welfare, and to allow for the continued operations of the Village, and to meet the legal requirements of certifying the necessary levies and shall therefore take effect and be in force immediately upon its passage.
