

RESOLUTION NO. R-25-08

TITLE: APPLICATION FOR FEDERAL (STBG) FUNDS

A RESOLUTION ALLOWING THE MAYOR TO APPLY FOR FEDERAL SURFACE TRANSPORTATION BLOCK GRANT (STBG) FUNDS PROGRAMMED BY THE AKRON METROPOLITAN AREA TRANSPORTATION STUDY (AMATS) TO CONSTRUCT CLINTON ROAD IMPROVEMENT PROJECT AND DECLARE AN EMERGENCY.

WHEREAS, The Clinton Road Improvement Project is Important to the Village; and

WHEREAS, this Importance is a need to the Village of Clinton; and

WHEREAS, Clinton Road is in need of drainage improvements, widening and resurfacing to address truck traffic and increased volume.

NOW, THEREFORE, BE IT RESOLVED by the Council of the Village of Clinton, State of Ohio:


SECTION 1. That the Mayor is hereby authorized to apply for Federal Surface Transportation Block Grant (STBG) Funds programmed by the Akron Metropolitan Area Transportation Study (AMATS) for the following Resurfacing Project


(1) Clinton Road Improvement Project, widening the roadway, improving drainage and resurfacing the roadway; From Cleveland Massillon Road to the Village Limits; and Estimated Cost of 2,200,000.00


SECTION 2. That the Village acknowledges and understands the AMATS "Funding Policy Guidelines" and confirms to the best of its knowledge that the information contained in the project application is accurate, that it intends to diligently pursue that project, and that a local share is required to match federal funds.

SECTION 3. That it is hereby found and determined that all formal actions of the Council concerning and relating to the passage of this Resolution were taken in an open meeting of this Council and that all deliberations of this Council and of any of its committees that resulted in such formal action were meeting open to the public and in compliance with the law.


