

**RESOLUTION NO. R-25-14**

**A RESOLUTION AUTHORIZING AND APPOINTING VARNEY, FINK & ASSOCIATES AS VILLAGE FISCAL OFFICER AND AUTHORIZING AND DIRECTING THE MAYOR TO ENTER INTO A THREE-YEAR CONTRACT, AND DECLARING AN EMERGENCY.**

**WHEREAS**, Varney, Fink & Associates was previously appointed to the position of acting Village Fiscal Officer for the Village of Clinton, Ohio for 2016.

**NOW, THEREFORE, BE IT RESOLVED** by the Council of the Village of Clinton, County of Summit, Ohio as follows:

**Section 1:** That, Varney, Fink & Associates is hereby appointed to the position of Village Fiscal Officer for the Village of Clinton, Ohio for calendar years 2026, 2027, and 2028.

**Section 2:** The Mayor is hereby authorized and directed to enter into an agreement, in a form substantially similar to the one attached hereto as Exhibit "A," with Varney, Fink & Associates for time period.


**Section 3:** Should the rates for services be increased by the Village Fiscal Officer appointed hereunder during the term of this appointment and agreement, such appointment hereunder shall be subject for review.

**Section 4:** That all Resolutions and Ordinances which are in conflict with this Resolution are hereby replaced and/or rescinded to the extent they conflict.



**Section 6:** That this Resolution is hereby declared to be an emergency measure necessary for the immediate preservation of the public peace, health, safety of the Village residents and to allow for the continued operations of the Village Fiscal Office and all departments and shall therefore take effect and be in force from and immediately after its passage.
