Mrs. Godwin said the Safety Committee was scheduled for tonight but nothing pressing – all under control regarding the fire levy. The next fire levy meeting will be held September 23rd at 7:00 PM. Bud McDaniel said the information provided about the levy has been well received.

There will be a Finance Committee meeting on October 5, 2021 at 6:00 PM.

Mr. Goch sent out a power point presentation (attached) regarding Warwick Park Lighting Options. Also discussed was removal of poles and fixtures, keeping the scoreboard but taking it down. This field has not been used for so long, it was decided to discontinue the lighting. Lights can be rented for \$250 a day if desired. The cost is \$4,900 to take down the existing poles and fixtures and leave stubs there so we can use in the future.

Mr. McDaniel made a motion to remove the poles and fixtures and de-electrify the park for \$4,900, second by Mr. Rash.
