# Village of Clinton Regular Council Meeting Minutes Of

## Thursday, November 4, 2021

## Approval of Council Minutes

She challenged the 571 who chose not to vote and explained why voting is so important and what the defeat means to the Village and the fire services. She asked those who chose to vote no to come forward with better solutions. She loves this community and feels we need to come together and support our fire department.

## First Readings

## Ordinance No. O-21-26

An Ordinance Amending Ordinance No. O-20-22, Establishing the Pay Rates for Certain Employees, Effective November 1, 2021, and Declaring an Emergency.

Mrs. Gensimore made a motion to set aside the three-reading rule, second by Mr. McDaniel.

Roll call: Conroy, Goch, Rash, Gensimore, McDaniel, and Godwin voted yes. Motion passes.

Mrs. Gensimore made a motion to adopt, second by Mr. McDaniel.

Roll call: Goch, Rash, Gensimore, McDaniel, Godwin, and Conroy voted yes. Motion passes.

New Business - Nothing to report.

## Council General Discussion

Mr. McDaniel said at 6:30 PM on November 11, Veteran's Day, there will be a Candlelight Vigil at the OVMP and on December 4, there were be a Christmas tree lighting from 5 to 7 and Santa will show up for that.

Mrs. Gensimore stated the Northwest School District will hold a drive through Veteran's parade. The Historical Society is putting together holiday baskets to be delivered the beginning part of December for those in need.

# Presentation of Purchase Orders and Bills for Approval

Mr. McDaniel motioned to approve the purchase orders and pay the bills as presented, second by Mr. Rash.

Roll Call: Rash, Gensimore, McDaniel, Godwin, Conroy, and Goch voted yes. Motion passes.

# Street Commissioner's Report

Mr. Siegenthaler, who is retiring today, introduced Kevin White who will be the new Street Laborer for the Village of Clinton.

He reported an accident involving a guard rail. Met with Jason Popiel to discuss closing Eastern, Grill, Edwards, and Clinton roads all summer long and we decided the traffic flow during this time. The highway will be open, you just can't cross it.

Mr. White will check with Mrs. Weirick on the Village finances for a Community Block Grant for more sidewalks.

They are waiting on the funds to see what happens to North Cleveland-Massillon Road next year. If we don't get the funds, we will need to come up with another option.

The salt spreader has been put on the truck. Mr. Siegenthaler has brought Mr. White up to speed on the key issues he will deal with in this position.

Mr. Siegenthaler asked that Council allow Mr. White to purchase a new chain saw as he has used his own personal one on the job so far.

Mrs. Gensimore made a motion authorizing Mr. White to purchase a new 20-inch chain saw, second by Mr. Rash.

Roll Call: Gensimore, McDaniel, Godwin, Conroy, Goch and Rash voted yes. Motion passes.

Mayor Allega presented Mr. Siegenthaler with a plaque and other gifts from Council and staff for all his hard work and dedication for 28 years. He will be greatly missed and we all wish him the best in the years to come. This portion ended in a well-deserved applause.

Motion by Mr. Rash to adjourn, second by Mr. McDaniel. Meeting was adjourned at 7:22 PM.
