

**Village of Clinton**  
**Regular Council Meeting Minutes**

**Tuesday, April 20, 2021**

Mayor Clarissa Allega called the meeting to order on Tuesday, April 20, 2021, at 7:00 PM. in Clinton Village Hall. The Pledge of Allegiance was led by Diane Gunter and recited by all those present.

Roll Call: Council Members Present: Louis Rash, Marissa Gensimore, Ellen Conroy, Jan Godwin; and Kent Goch. Mr. McDaniel was absent.

Others Present: Terry Siegenthaler, Street Commission; Wayne Conroy, Fire Chief; and Diane Gunter, Resident.

Approval of Minutes: April 6, 2021 Council Meeting Minutes

Mrs. Godwin motioned to accept the minutes as written, second by Mr. Rash.

Roll Call: Rash, Gensimore, Godwin, Conroy, and Goch voted yes. Motion passes.

Solicitor's Report: No report.

Unfinished Business:

Chief Conroy did get some numbers from Central for dispatch but they are not permanent numbers. Initially till the end of the year the cost could be \$30 to \$32 per call. Beginning January 1, 2022, the cost per call could increase to \$42 to \$45 per call. Red Center quoted around \$40.90 to \$45 per call. Swiss Com will be sending me a quote as well and the Chief will forward that information on to Council.

The generator was installed which will ensure we have power should we have an outage.

Mayor's Communications:

There is a BZA meeting tomorrow night.

The Summit County's max vaccine site at the Summit County Fairgrounds is giving Moderna instead of Johnson & Johnson vaccines.

FEMA is accepting COVID-19 Funeral Assistance Applications and provides funds if the death certificate says the cause was Covid-19, retroactive to last January.

Summit Soil provided us some 2 ft. trees. They are in New Franklin and Terry Siegenthaler will be getting them. We will be deciding where they will go as Summit Soil wants to know where they will be planted.

Council Communications

Mrs. Gensimore secured a minister for the Memorial Day event. She's working on finding a speaker as well. The Northwest Band will be playing. She explained the planning of the event so far.

The deadline for the new Community News may be some time in May as it will come out in June.

Citizens' Comments

Mrs. Gunter asked about the events we will be having and the rules that will be in place relative to Covid-19. Mayor Allega explained that precautions apply - no more than 10 at a table/group, social distancing, etc.
