#### Mayor's Communications

### **Council Communications and Council Committee Reports**

Mrs. Gensimore said she received communications from Canton Data Print that the Newsletter is on track to be delivered to our homes September 1. The Village is on the front page.

#### **Citizens Comments**

Alice Bogdansky spoke on the 3<sup>rd</sup> reading of the proposed Mobile Food Truck Ordinance. She is against the passage of this legislation. She provided her concerns as to why this is not necessary.

Mr. Rash asked Mr. McDaniel about the status of Broadband. Mr. McDaniel explained that it's fiber, very stable, and will provide a competitive service for residents and other communities. He further explained what he is aware of at this time and that he will continue to work with Summit County on this issue. There is more we do not know right now. Funds will be available thru an NCIA grant the County is working on. The letter the mayor was asked to sign supports this effort.

Mr. McDaniel made a motion to authorize our mayor to submit this letter of support to help secure funding to make this happen, second by Mr. Rash.

Roll Call: Conroy, Goch, Rash, Gensimore, McDaniel, and Godwin voted yes. Motion passes.

Mayor Allega said it has been a pleasure to serve as the Village Mayor and thanked council for their support and working so well together. Chief Conroy thanked the Mayor as well. Mrs. Gensimore said she handled so many things we were hit with and steered the ship well. Mr. McDaniel has enjoyed working with Mrs. Allega. Mayor Allega read the oath of office to swear in Mr. McDaniel effective September 1, 2022.

### **Council General Discussion**

Mr. Rash said Jeff Ferjutz, zoning inspector, needs more work hours with all the building going on. Mr. Rash said there are things that are not being done and not acceptable. Mrs. Gensimore said Mr. Ferjutz has done a lot more during his tenure than ever before. The mayor indicated that the Finance Committee needs to be involved and soon the budget will be reviewed.
