

**Village of Clinton  
Regular Council Meeting Minutes

August 4, 2022**

Mayor Clarissa Allega called the meeting to order on Thursday, August 4, 2022 at 7:00 PM in Clinton Village Hall. The Pledge of Allegiance was led by the Alice Bogdansky.

Our Korean War Veterans program at the Wall went very well.


